"Imagines of the disasters of September 11, 2001 have been forever seared into the collective American conscience. Fire. Dust. Explosions. These events have had a monumental impact on our way of life. Many lives were lost on that September day and in the ensuing rescue efforts.

Zeta Beta Tau has not escaped the impact of the 9/11 tragedies. At the time of writing, the Fraternity has received word on the deaths of eight ZBT Brothers. Our sincerest condolences are extended to the families, friends and Chapter Brothers of the following men:

Our condolences are also extended to the families, friends and Chapter Brothers of those men of ZBT who also perished in the tragedies of September 11 but are not reported above.

In honor of our fallen Brothers, the

Supreme Council of Zeta Beta Tau unanimously voted to bestow ZBT's Man of the Year Award upon all members of our Fraternity who perished in the events of September 11 and in subsequent rescue efforts. The Man of the Year Award is traditionally presented by the National Fraternity to a Brother who has made great contributions to the community in which he resides.

Our duty as Brothers of Zeta Beta Tau is to assist those around us, to be vigilant in our work to improve our society and to remember our Brothers in times of crisis.

Out of the ashes of September 11 has arisen a great outpouring of generosity and a renewal in the patriotic American spirit. These events have demonstrated that indeed we are all members of a greater community, the Brotherhood of Man.

To assist in the disaster relief efforts, and show their commitment to better the Brotherhood of Man, several ZBT Chapters and Colonies mounted fundraising efforts immediately after September 11. The following undergraduates groups are to be commended for their efforts in this regard:

- ◆ Phi Delta Psi Chapter at Southern New Hampshire University
- ◆ Beta Tau Colony at Emory University
- ◆ Eta Colony at the University of Michigan
- ◆ Beta Tau Colony at the University of Colorado - Colorado Springs.

These Chapters and Colonies spon-

sored philanthropic activities to benefit disaster relief efforts and the survivors of the 9/11 tragedies.

Out of the ashes arose many extraordinary tales of heroism and sacrifice. The heroic spirit exhibited by many in the wake of the tragedies is best epitomized by former New York City Mayor Rudolph Giuliani. Mayor Giuliani is credited with orchestrating the massive rescue efforts in New York City and bolstering the low morale of New Yorkers directly after the tragedies. In recognition of his extraordinary efforts, Zeta Beta Tau Fraternity's Supreme Council unanimously voted to bestow the Gottheil Medal upon Mayor Giuliani.

The Gottheil Medal is presented to individuals who make great contributions to their communities and whose work advances the Brotherhood of Man. Past recipients include Elie Wiesel, Edgar Bronfman, Eleanor Roosevelt, President Franklin D. Roosevelt and Justice Louis Brandeis.

In recognition of the significant impact of the events of September 11, ZBT's Supreme Council also enacted the "Resolution Honoring Those Effected by the Events of September 11, 2001."

Out of the ashes of the World Trade Center, the Pentagon and the airplane in Pennsylvania arises a poignant reminder of our duty as Brothers of Zeta Beta Tau to assist those around us, to be vigilant in our work to improve our society and to remember our Brothers in times of crisis.

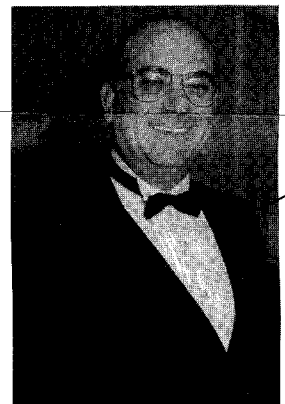

Siegman Honored as America's Point of Light

Zeta Beta Tau's 2001 Man of Distinction, Greg Forbes Siegman, was honored on February 20, 2002 as the nation's Daily Point of Light. Brother Siegman, who joined ZBT as a freshman at Tulane University in 1991, is founder of the Illinois-based 11-10-02 Foundation, best known for its BrunchBunch.com Program. 11-10-02 also distributes tens of thousands of dollars a year in grants and scholarships to deserving youth and remains devoted to the principle that young people can do anything. In addition to running the foundation, Siegman devotes most of his time to teaching and speaking at schools and conferences around the country.

President George Bush, President George W. Bush and President Bill Clinton are among those sending congratulatory letters to Siegman for this special honor from the Points of Light Foundation.

"We search for programs that meet community needs and lead to long-term solutions; efforts that build connections between the community; efforts that are of at least six months in duration and efforts that demonstrate measurable impact. For demonstrating volunteer service that meets all of these criteria, Greg Forbes Siegman is truly deserving of recognition as a Daily Point of Light," states Robert Goodwin, President and CEO of the Points of Light Foundation.

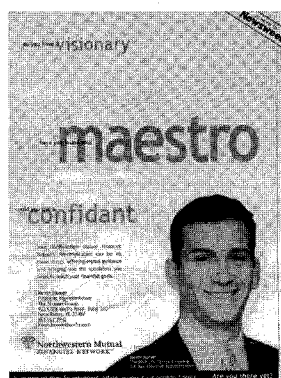

Zeta Beta Tau mourns the loss of Brother **Barry D. Siegel** (BH, Bowling Green, '52). Brother Siegel served as Executive Secretary of the Fraternity from 1960 to 1971. Those who met and worked with Barry often referred to him as "Mr. ZBT." He was much the raconteur, with a knack for entertaining and telling great stories. Barry is credited with bringing technological advances to the National Fraternity's office and ambitiously pursuing undergraduate expansion. Following his service to ZBT, Brother Siegel worked in banking, marketing and catering. Brother Siegel is survived by his mother, two children and two grandchildren.

Legendary broadcaster **Richard (Dick) Schaap**, (B, Cornell, '55), died recently at the age of 67. Brother Schaap's career spanned more than 50 years and included work in print, radio and television. Brother Schaap is survived by his wife and six children.



Benjamin P. Klein

Benjamin P. Klein (KΦ '03, *Alfred*) died on February 10, 2002 at the age of 21. At the time of his death, Ben was Kappa Phi Chapter's Treasurer. An economics major, Ben was known to be passionate about everything that he did. He was an accomplished violinist and was a member of a number of orchestras and choirs. He enjoyed lively conversation and debating about politics and music.

Ben was known for his ability to make people laugh and for his compassion and concern for others. At a memorial service held in Vermont, he was described as "inherently moral."

I never met Ben. Nevertheless, I feel a profound sense of loss for a Brother who left us much too soon. Had I known Ben, I think that I would have liked him. He embodied the qualities for which ZBT stands—compassion, concern for others, a passion for life and ideas, and making a difference. The ZBT Credo asks us to dedicate ourselves to Intellectual Awareness, Social Responsibility, Integrity and Brotherly Love. From what I have learned about Ben, these were principles that were important to him and ones that he practiced in his daily life. The Brotherhood we call ZBT is diminished for having lost Brother Ben Klein.

Dear Brothers,
On February 1, 2002 the Zeta Beta Tau Foundation celebrated its 52nd Birthday. I hope you will join me, and all of your Brothers, in making this year a "birthday" to remember! We've accomplished a lot in the first 52 years. Through May 31, 2001 we've awarded 2,922 scholarships, totaling \$1,110,480.00 over our 52 years, and we've granted more than \$800,000 to the Fraternity for leadership and educational programming in the past 20 years. While we are proud of these numbers, we need to dramatically increase the Foundation's capital in order to provide for the growing needs of our undergraduates, whether it is for scholarships or for additional programming and staff. This past year the Foundation hired its first full-time staff person, which has enabled us to begin to implement new programming and be more responsive to our constituents (alumni, parents and undergraduates).

Recently, we implemented new annual giving clubs, while retaining the "old, cumulative clubs. Members in these clubs will receive a special ZBT lapel pin at the end of each fiscal year (May 31st), as well as other benefits, such as special newsletters, etc. The annual giving clubs are designed to build the Foundation's General Fund. We have also started to communicate with our donors via e-mail, and we are always trying to make sure we have current addresses for our alumni. Please make certain that you notify us of your e-mail and current mailing address by sending an email to gregg@zbtnational.org. During this year, many alumni have "stepped up" and provided much needed funding for leadership programs such as the Fraternity's Regional Conclaves. Others have provided funding for our Heritage projects, and, of course, many of our members have established funds for their own Chapter's scholarship or educational use. Whether your interest is on a national, regional or local basis, the ZBT Foundation welcomes your contributions. If you are planning an alumni event for your Chapter, please feel free to contact the National Office for assistance with mailing addresses, etc. Let us know about your gathering, and we will try to get a representative of the Foundation or National Fraternity to attend, and to fill you in on what is happening with the Fraternity and the Foundation.

Finally, I would be remiss if I didn't take this opportunity to thank all of the members of our Board of Directors, Executive Director Jonathan I. Yulish, Development Officer Gregory L. Puls, and our Chief Financial Officer, Philip M. Waxberg, for their hard work and dedication in the day-to-day administration of the Foundation, and the implementation of its goals. Without their efforts, we could not exist. I welcome any suggestions or comments you may have as to how your ZBT Foundation can better serve its constituency in the coming year.

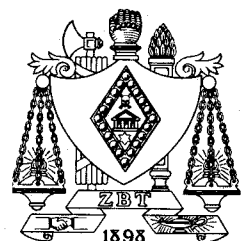
THE BRUMMER CUP Alpha Zeta University of Florida

Zeta Beta Tau 2000-2001 Awards

THE PRESIDENTIAL CITATIONS

During his term in office, National President Irv Chase, Esq. began the tradition of annually presenting several Chapters and Colonies with Presidential Citation Banners. These Chapters and Colonies have distinguished themselves in some manner and bring prestige to our Fraternity through their good work. They truly embody the ideals of our Fraternity. The successes of these groups are grounded in preparation, hard work and continual examination of programs and procedures.

Mu, Boston

A model of successful goal setting and achievement, Mu Chapter enjoys the presence of a highly involved alumnus advisor who has set lofty goals for the Chapter and helped it achieve those goals. The Chapter perennially ranks among the top academic-performing fraternities on its campus. Members regularly participate in a mentoring program for elementary school students and volunteer at a local soup kitchen. They traveled to Washington, D.C. to march in the Mass Jewish Appeal in March and sponsored a holiday party for children enrolled in a local early learning program in December.

Alpha Delta, University of Southern California

A model of success through consistency, Alpha Delta has time and again proven itself to be a prime example of superior operations and participation in its various communities since its rechartering in 1995. Since the time of its reinception, the Chapter has been named the best Greek organization on its campus and received multiple awards from the National Fraternity. Its advisors have also been recognized for their unflagging sup-

port. During this academic year, Alpha Delta sponsored two philanthropic events to benefit the Foundation for the Junior Blind. Members may be found participating in the campus Entrepreneurship Society, Army ROTC, Orientation Committee and Order of Omega. The Chapter publishes two alumni newsletters and assists its alumnus advisor in sponsoring an alumni Super Bowl social event. Internally, the Chapter focused on improving its academic standing among campus fraternities and went from 11th place in the spring of 2000 to fourth place of 20 fraternities in the fall of 2000. It instituted minimum membership standards and attendance standards to improve its retention of members and participation in the life of the Chapter. Alpha Delta has not rested on its laurels, but continues to examine issues critical to its livelihood.

Zeta Upsilon, University of Texas-Dallas

Zeta Upsilon consistently ranks among the best fraternities on its campus and among ZBT chapters. It shows no signs of flagging in its commitment to the pursuit of excellence. The success of Zeta Upsilon is not limited to one area of programming. Academically the Chapter ranked first and second among campus fraternities in the spring and fall terms. It is a positive force in its community, conducting a clothing drive for Goodwill Services, staffing a booth during a week-long community festival and sponsoring a canned food drive to benefit a local home for children with AIDS. To benefit its members, the Chapter annually conducts retreats, an intrafraternity Olympics competition and several internal education seminars. At the University of Texas-Dallas, it is certainly true that "it's great to be a ZBT."

Eta Beta, Oklahoma State University

In a relatively short period of time, Eta Beta established strong traditions of service to the Brotherhood of Man and commitment to the words of ZBT's Ritual and Credo. Brothers participated in their university's "Into the Streets" program, which involved assisting a community church with its outdoor fair. It participated in the university's "Shack-a-Thon" contest to raise funds for the homeless in neighboring communities. Members contributed more than 235 hours of service to this project and raised more than \$200 to benefit Habitat for Humanity. In promoting responsible and healthy social interaction, the Chapter sponsored an all-day ZBTahiti party that was attended by more than 2,000 members of the university community. Not only was the party in full compliance with ZBT's risk management policy, it was completely alcohol-free. For the benefit of its membership, Eta Beta sponsors regular presentations given by outside speakers on leadership development, volunteerism and etiquette. The Chapter also implemented the Judaism Enrichment Program, in which the Brotherhood Development Director regularly presents information on Jewish culture and history. While in the youth of its history, Eta Beta has quickly gained a place of prominence amongst the premiere chapters of our Fraternity.

THE EDWIN B. MEISSNER AWARD Beta Mu, Rider University

Named for the patriarch of a prominent family of ZBT men who gave years of service to the National Fraternity, the Meissner Award is presented to the Fraternity's most improved Chapter.

This year's award was presented to Beta Mu Chapter at Rider University. At the start of the academic year, the Chapter was faced with the dire problem of losing its campus housing and recognition due to lack of membership and organizational viability. Rather than allowing the Chapter to fade away, its members came together in a concerted effort to improve the quality of the Chapter. The result has been nothing short of miraculous.

Working with limited resources of approximately 20 Brothers, the Chapter raised almost \$900 to benefit the Multiple Sclerosis Society and the mother of a Chapter member who suffers from MS. It documented 20 hours of community service per Brother, including work with Habitat for Humanity and the Ronald McDonald House. Members participated in a basketball tournament to benefit the Sunshine Foundation and in a local Haunted Hay Ride program by helping entertain local grammar and middle school children the night before Halloween. Members are active in many campus activities serving as campus tutors and orientation advisors. Two Brothers play varsity athletics and the Chapter won its campus' Greek volleyball and ultimate Frisbee tournaments. The Chapter sponsored a study program for members and offered tutoring services, which resulted in securing the Chapter a second place ranking on campus for its cumulative grade point average. Beta Mu also hosted its annual Big Brother/Little Brother events to promote bonding among Chapter members.

THE ROSWELL "BUDDY" MESSING AWARD

Throughout Convention ZBT presented awards to individual Brothers for their achievements in many facets of collegiate life including academics, participation in campus activities and dedication to the success of their chapters and colonies. By virtue of having earned many of the Fraternity's Individual Brother Achievement Awards, several men have distinguished themselves to qualify for the Messing Award.

This award is named in honor of Roswell "Buddy" Messing. Buddy was initiated in 1938 into Omega Chapter at the University of Missouri. Throughout his ZBT career, Buddy served as trustee to Omega Chapter and was often sought for counsel by the National Fraternity. His fraternal spirit remained strong until his death in the late 1980s.

The Messing Award is presented to the undergraduate man who most fully embodies the precepts of our Fraternity. This year's award was presented to Adam F. Poniatowski (AZ, Florida).

Brother Poniatowski served as Alpha Zeta Administrative Vice President. He coordinated the first all-Chapter "ZBT Olympics" and played a key part in completing his Chapter's campus awards application, for which the Chapter received accolades

for academic and scholarship programming and was named the campus' Most Outstanding Fraternity for the year. Brother Poniatowski is pursuing a chemical engineering degree and boasted an impressive 3.78 cumulative GPA at the completion of his junior year. His dedication to academic success is evidenced by his being named to the Dean's List of the College of Engineering, as a National Collegiate Engineering Scholar and membership in the American Institute of Chemical Engineers.

THE MAXWELL HYMAN CHAPTER ADVISOR AWARD

**Bob Culter and Ron
Rosner, Beta Zeta Epsilon
Chapter Advisors**

The Maxwell Hyman Chapter Advisor Award is named for a founder of Phi Sigma Delta Fraternity and a member of that Fraternity's Alpha Chapter at Columbia University. Brother Hyman figured prominently in the early history of Phi Sig as an advocate for, and trainer of, Chapter advisors.

History shows that those Chapters that enjoy long-term success are assisted by at least one dedicated alumnus advisor. These men provide a wealth of experience and knowledge to our undergraduates. We thank all of those who serve as Chapter advisors and work to improve the quality of ZBT's undergraduate fraternity experience.

The 2001 Maxwell Hyman Award was presented to two advisors whose work and dedication have resulted in the sustenance of a great Chapter. Congratulations to Bob Culter and Ron Rosner of Beta Zeta Epsilon Chapter at the University of Maryland-College Park.

Since the time of the Chapter's chartering only five years ago, it has quickly risen to rank among the best fraternities on its campus and within ZBT. A great factor in its success is the involvement of its advisors who serve as invaluable resources to the Chapter leaders and as role models of success among the dedicated advisors of ZBT.

THE SID LUCKMAN AWARD

**Delta Chapter,
Columbia University**

This award celebrates a great fraternity man and football star, Brother Sid Luckman. Brother Luckman, a member of the National Football League Hall of Fame, brought great prestige to his Delta Chapter at Columbia University and ZBT in general. In honor of Brother Luckman, this award is presented to those Chapters and Colonies that show outstanding participation in varsity athletics. The qualifying Chapters and Colonies have a minimum of either 10 Brothers or 20 percent of its membership participate in varsity athletics during the academic year.

The 2001 Sid Luckman Award was presented to Delta Chapter at Columbia University. The Chapter boasts 20 varsity athletes, representing about 60 percent of the Chapter's undergraduate membership.

THE FRAUENTHAL AWARD

**Beta Zeta Epsilon,
University of Maryland-
College Park**

Dr. Henry Frauenthal, an honorary member of ZBT, first presented this award at the 1914 ZBT Convention. The award was initially presented to the Chapter that most distinguished itself in

athletics of any kind, either varsity or intramural. Today we present the Frauenthal Award to those Chapters and Colonies that excel in intramural athletics. Chapters and Colonies that qualify for this award have placed first in at least one over-all intramural sports competition or won any three individual campus or IFC intramural sports competitions in the past academic year.

The 2001 Frauenthal Award was presented to Beta Zeta Epsilon, University of Maryland-College Park. The Chapter won the intramural singles and doubles tournaments in both tennis and racquetball and also reached the finals of its campus' intramural soccer tournament and ranked fourth in its 5-on-5 basketball tournament.

THE THEODORE G. RICH- ST. LOUIS ALUMNI ASSOCIATION AWARD Alpha Zeta, University of Florida

As members of ZBT we are continually challenged to work for the betterment of the Brotherhood of Man. Many ZBT Chapters and Colonies accept the challenge to work to improve their various communities. First awarded in 1950, the Theodore G. Rich-St. Louis Alumni Association Award is presented to the Chapter that exemplifies ZBT's commitment to the service of the Brotherhood of Man. To qualify for this award, Chapters must have documented a minimum of 10 hours of community service work for each Brother, or sponsor a significant service project.

The 2001 Theodore G. Rich-St. Louis Alumni Association Award was presented to Alpha Zeta Chapter, University of Florida. The Chapter sponsored a powderpuff football tournament in the fall semester to benefit the local AIDS network and raised more than \$5,000. The Chapter made weekly donations of food to a local homeless shelter throughout the academic year and sponsored an endangered

species making monthly donations to "ZBTurtle." Brothers of Alpha Zeta worked together to raise more than \$21,000 for charitable organizations and contributed an average of 15 hours to community service during the academic year.

THE JOSEPH E. GLASER AWARD

**Gamma Chapter,
Northwestern University**

Named in honor of the long-time advisor to the Beta Delta Chapter at Rutgers University, the Joseph E. Glaser Award is presented to the Chapter that demonstrates its commitment to the community through philanthropic endeavors. Qualifying Chapters and Colonies have raised and donated a minimum of \$100 per Brother or sponsored a significant philanthropic event in the past academic year.

The 2001 Joseph E. Glaser Award was presented for the fourth consecutive year to Gamma Chapter at Northwestern University. The Chapter raised a remarkable \$37,700 benefiting charitable organizations. Through the unflagging commitment of its members, the Chapter raised \$34,700 for the local campus dance marathon. Gamma Chapter has raised the highest total amount of money for the dance marathon among all campus organizations for 26 of the last 27 years, with this year being no exception. The Chapter also sponsored the "Fence-In" event, raising \$3,000 in memory of a Chapter member who passed away, due to complications from leukemia and benefited the Leukemia Research Foundation.

THE ALEXANDER "BABE" LEWIN AWARD

**Beta Zeta Epsilon,
University of Maryland-
College Park**

This award honors Chapters that maintain active communication with their alumni. Named for an alumnus of Phi Sigma Delta Fraternity who served for many years on the professional staff of that Fraternity, the

Alexander "Babe" Lewin Award is presented to the Chapter that values the resources and experiences that are afforded by its alumni members. Qualifying Chapters must have produced and mailed at least two alumni newsletters in the academic year, provided the National Office with updated alumni address information and hosted events to encourage alumni participation.

This year's recipient is Beta Zeta Epsilon Chapter, University of Maryland-College Park. Using technology to its advantage, the Chapter circulated monthly alumni updates and its newsletter via email. The Chapter reinforced ZBT's commitment to Brotherhood for life by sponsoring an alumni barbecue in the fall semester, which attracted about 45 alumni. In the spring, the Chapter celebrated its university's success in the NCAA basketball tournament with alumni at a gathering in the Chapter house, held in conjunction with a televised basketball game and sponsored a trip to Atlantic City, New Jersey, to encourage social interaction of senior members and alumni Brothers.

THE BARRY D. SIEGEL AWARD

**Zeta Upsilon,
University of Texas-Dallas**

The Barry D. Siegel Award recognizes excellence in new member recruitment. Barry Siegel served as ZBT Executive Secretary from 1960 through 1971. An alumnus of Beta Eta Chapter at Bowling Green State University, Brother Siegel was known for his energy, enthusiasm and innovative thinking. He stressed the need for the education of Brothers on fraternity management skills, including recruitment.

To memorialize the contributions of Brother Siegel, ZBT presents this award to the Chapter or Colony that shows the greatest success in recruitment. This success is due to training, education and an emphasis on continued growth. Qualifying Chapters and Colonies must either initiate 35 men or show a growth of 35 per-

cent in its initiation rate over the average of its previous three-year initiation rate.

The recipient of this year's award is Zeta Upsilon, University of Texas-Dallas. The Chapter broke all recruitment records on its campus, initiating 28 men in the fall and six in the spring, doubling its previous three-year recruitment average of 17 men. It now boasts a membership of approximately 50 men.

THE SOBEL AWARD

**Beta Lambda,
San Diego State University**

First presented in 1915, the Sobel Award is named for the Brother who sponsored the initial prize, Isidore Sobel of Theta Chapter, University of Pennsylvania. Brother Sobel recognized an underlying purpose of ZBT and the true purpose of every student's presence at an institution of higher learning, that of academic success.

The Credo of ZBT challenges each member to pursue intellectual awareness. Qualifying Chapters and Colonies have demonstrated a marked improvement in scholastic standing in the past academic year. These Chapters and Colonies have shown a positive change in grade point average of either .15 in one semester or .30 in one year.

Beta Lambda, San Diego State University is the 2001 Sobel Award recipient. The Chapter posted an impressive cumulative grade point average improvement of .21 points in one semester. It has put forth a concerted effort to improve the academic standing of its members and thus the Chapter as a whole.

THE BIJUR AWARD

**Gamma, Northwestern
University**

Named for its first sponsor, Judge Moses Bijur of the Delta Chapter at Columbia University, the first presentation of this award dates back to 1915.

Fraternity provides a great vehicle for academic success. Chapters that have learned to maximize their resources to promote intellectual awareness are

worthy of our highest praise. Qualifying chapters must have a minimum of a 2.75 grade point average on a 4.0 scale, but their grade point average must be at least two-tenths of a point greater than the campus all-men's average.

This year's Bijur Award was presented to Gamma Chapter at Northwestern University for its commitment to academic excellence and for earning an over-all Chapter cumulative grade point average of 3.43 on a 4.0 scale in the past academic year.

THE LEE DOVER AWARD

**Alpha Zeta,
University of Florida**

Lee Dover, ZBT's second Executive Secretary, is credited as being one of the primary architects of our Fraternity. He guided ZBT through two world wars and the Great Depression—times that were fatal to many national Greek organizations. Brother Dover advocated that ZBT Brothers were men of integrity and men of learning. To honor his legacy, ZBT presents the Lee Dover Award for internal Chapter programming. Qualifying Chapters have improved the quality, integrity and scope of learning of their members.

The recipient of the 2001 Lee Dover Award was Alpha Zeta at the University of Florida for providing exemplary programming to its members. The Chapter sponsored all-member fall educational programs on risk management, alcohol use and abuse, male/female relationships, sexual assault, minority population issues and resume writing and interviewing skills. It hosted a weekly dinner for various university faculty members and sponsored a Brothers-only basketball tournament, Brotherhood paintball outing and Big Brother night.

ZBT Foundation Giving Societies

Introducing the Zeta Beta Tau Foundation's annual giving societies! These new societies will allow us to better recognize the alumni who so generously support us in our efforts to provide more scholarships and better academic and leadership programs to the members of Zeta Beta Tau Fraternity.

1898 Society

The 1898 Society recognizes all donors who support the Zeta Beta Tau Foundation with \$250 or more in unrestricted gifts. Members will be listed in the Donor Roll. Diamond: \$2,500+; Gold: \$1,000-\$2,499; Silver: \$500-\$999; Bronze:

\$250-\$499. All gifts made during the fiscal year (June 1-May 31) are credited towards membership. Membership in the 1898 Society includes membership in the Founders Society.

Founders Society

The Founders Society recognizes all donors who support the Zeta Beta Tau Foundation in unrestricted gifts with \$1 for each year since the Fraternity's founding. Members will receive special recognition in the Donor Roll. All gifts made during the fiscal year (June 1 - May 31) are credited towards membership. Membership in the Founders Society is included in membership in the 1898 Society.

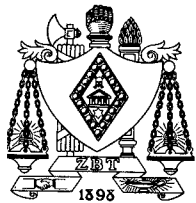
