SERVING HIS COUNTRY



Martin Frost holds many titles—the most senior Member of the Texas Congressional delegation; senior Southern Democratic Member; and the Ranking Member

of the House Rules committee.

Since the retirement of **Benjamin Gilman** in 2002, **Martin Frost (Missouri '64)** has been the only Zeta Beta Tau Fraternity brother in the United States Congress.

Representing the north central Texas area including parts of Dallas, Forth Worth, Arlington, Duncanville and Cedar Hill since 1978, Frost has been a leader in the state, in the Congress and the Democratic Party. From 1999 to 2003 Frost served as the House Democratic Caucus Chairman

and served on the committee which created the new Department of Homeland Security.

Graduating from the University of Missouri in 1964 with a degree in Journalism and History, Frost concluded a four-year undergraduate experience with ZBT that included a term as Chapter Secretary, editor of the school paper, and student body president.

Looking for a Jewish fraternal experience at college, Frost was introduced to ZBT before stepping on the campus in Columbia, MO. Although there were some non-Jewish members, the majority of the Brothers were Jewish. "My family was from Vicksburg, Mississippi," Frost stated.

Heading to school his freshmen year, Frost took the train from Dallas to St. Louis where he met up with a Vicksburg resident and family friend **Burt Fischer (ZBT)**. Fischer drove him to the campus

and introduced him to ZBT.

Frost lived in the ZBT house during the four years of his undergraduate membership. During that time Supreme Court Justices **Louis Kinder** and **Felix Frankfurter's (CCNY '02)** portraits hung in the Chapter House halls. Chapter Brothers included **Michael Ruby (Missouri '64)** of Skokie, IL the future editor-in-chief of U.S. News & World Report and **Neal Anders (ZBT)** of Wilkes-Barre, PA the future sports editor of the New York Times. The "school attracted a lot of top students in journalism," said Frost. "A lot of interesting people" were in the Chapter.

"Being a part of ZBT was a very important part of being a college student," concluded Frost. Two of Frost's daughters are members of sororities. He is married to Major General Kathy George Frost (U.S. Army) and a member of Congregation Beth El in Fort Worth, TX.

GW PRESIDENT RECEIVES PRESTIGIOUS PRIZE

The George Washington University President **Stephen Joel Trachtenberg (Columbia '59)** is one of four persons who received the Sabin Vaccine Institute's highest non-science prize. The Institute honored Brother Trachtenberg with its Humanitarian Award at a benefit dinner in New York City on May 14, 2003.

"Navigating the rise of an established and recognized academic institution to far greater heights of excellence and prestige is no mean feat, particularly in the nation's capital where a lesser figure would become overpowered by the politics and peculiarities that can impede progress," said Sabin's chairmen, H.R. Shepherd, about Trachtenberg's remarkable leadership of GW.

"I am humbled to be included in a group that has impacted humankind in such a positive way," said Trachtenberg. "But, in truth, this award truly recognizes the dedication and commitment of the entire GW community – from our world-class faculty and staff to the talented students that study in our classrooms and laboratories."

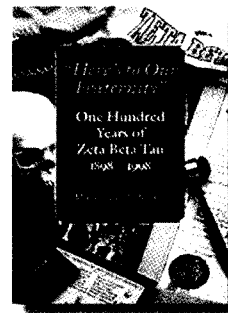

FROM THE NATIONAL PRESIDENT

I would like to share with you ZBT's vision – a vision that will once again make ZBT a 'Powerhouse of Excellence' at every campus across North America where we have a chapter. For the first time in over a decade, the Supreme Council – after careful analysis with input from undergraduate leaders, alumni and Greek advisors – has developed a Long Range Plan for our fraternity. After its adoption, the Supreme Council decided to make the following goals its priority:

1. To have 75% of our chapters rated by their Greek advisors as being in the top half of fraternities on their respective campus within 3 years
2. To have 1,250 initiates per year within 3 years
3. To have 100 chapters and/or colonies within 3 years

While I am certain that both the National Staff and Alumni volunteers are dedicated to spending their time and energy to accomplish these goals, it would be impossible to be successful without the assistance of our alumni. So – How can you help?!

Goal #1 – In order to have our chapters rated in the top half or hopefully higher – we need more alumni advisors. Experience has shown us that where we have active alumni advisors, we usually have successful chapters. Our undergraduates want and appreciate help and guidance from advisors.

Goal #2 is to have 1,250 initiates per year. In order to fulfill this goal, it is important to understand why growth is so important. First – membership is muscle! Recruiting and initiating men of quality will add new blood and programming dollars to our chapters. People develop relationships by sharing common experiences. So it follows that if our chapters have more brothers and more money, they will build tighter brotherhoods. As alumni, you can help by sending recruitment recommendations to the National office, which we will then forward to the appropriate chapters. There is a form on the back page to make recruitment recommendations. This past year, we proudly initiated over 980 Brothers. With expansion and a 7% growth rate per year, per chapter and/or colony – we will attain this goal.

Goal #3 is to have 100 chapters and/or colonies. As of today we stand at 75. This past year we closed 9 chapters, mainly due to lack of growth. We have developed specific plans to help our at-risk chapters, while at the same time continue to focus our efforts on expansion. How can you help? There are two ways. First, as mentioned above, you can serve as mentors for struggling chapters and colonies. In addition, you can give us leads of quality men who may be interested in starting group sat campuses at which ZBT does not currently have a presence.

With your help, ZBT will continue to be among the elite National Fraternities. This must be a collective effort. I am counting on our staff, alumni and undergraduate leaders to help us realize this vision.

ESTATE PLANNING IS FOR EVERYONE

It is a common misconception that only the highly affluent require the assistance of estate planners. This is simply not true. One of the basic purposes of estate planning, and why it applies to everyone, is that it allows an individual, and not the government, to determine who is to be the beneficiary of their assets after their death. Estate planners assist the client in achieving their objectives by gathering the relevant factual and emotional information, ascertaining the client's objectives and drafting legal documents to execute those goals.

If your estate is \$100,000 or \$100,000,000, your personal and financial objectives are equally as important. Inasmuch as the size of your estate may require various estate planning tools, each person should have at the minimum the basics, i.e. a Power of Attorney for Health Care, a Power of Attorney for Financial Matters and a Last Will and Testament. This article will briefly address the common issues that are present in each person's estate plan.

Meeting with an estate planning attorney may be unsettling because it forces one to think about his own mortality, which raises uncomfortable thoughts. If one is properly prepared for this first encounter, the meeting may proceed with greater discussion of the planning opportunities.

The first meeting between a client and the attorney serves multiple purposes. The client and attorney use this meeting to determine if their styles enable them to effectively work together. The attorney

poses questions and leads a discussion with the client in order to gather facts and determine objectives.

Preparation for the first meeting is a three-fold process. First, the client should prepare a list of all their assets and liabilities. This list should include apparent items such as any real estate, brokerage accounts, stocks, bonds, annuities and bank accounts. Less apparent items that may be overlooked, but should be included in the compilation of assets are life insurance policies, articles of artistic or collectible value.

Second, the client should, at a minimum, think about whom they would trust to make important health care and/or financial decisions in their absence. In addition, if there are minor children in the family, whom would they trust to take care of their children if they are no longer able to.

Third, the client should contemplate who the beneficiaries of their estate will be. Surviving spouses, children, family members and, in some cases, friends are the standard recipients. Within these classes the percentage of the estate to be distributed, the timing of the distribution and the means by which the assets should be held prior to final distribution are important decisions that should be discussed.

While most individuals are philanthropic while alive, it is important to consider continuing the tradition of giving upon one's death. Charities are often discussed

as potential beneficiaries to an estate plan. Not only does the estate receive the benefit of a deduction, if estate taxes are due, thus reducing the amount of estate taxes due, but the charity receives an infusion of capital to assist it with its services to the community. Serious thought should be given to which organizations have affected you over your lifetime and that your donation to that organization will enable them to impact the lives of others after you.

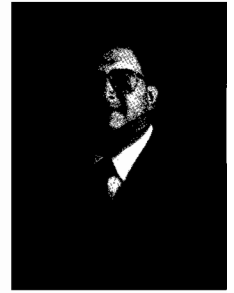
Even though this article briefly touched on the basic issues that arise in a first meeting with an estate planner, it should initiate one's thinking prior to the first meeting. Working with an estate planning attorney should be an experience resulting in peace of mind that your estate is in order while you are alive and that after your passing your wishes as to the ultimate beneficiaries of your estate will be carried out.

WASHINGTON WATCH



Editor's Note: It is the intention of this magazine to keep our alumni and their families updated on legislation pending in Washington affecting the fraternity system. Zeta Beta Tau Fraternity does not necessarily endorse any of the following legislation.

Fraternal Capital Caucus

In November of 2001, Patton Boggs LLP was retained as *pro bono* counsel for the North-American Interfraternity Conference's (NIC) government relations work. Services provided by Patton Boggs are being shared with the National Panhellenic Conference (NPC) and the National Pan-Hellenic Conference (NPHC), though no formal relationship exists between Patton Boggs and these entities.

The Fraternal Capital Caucus is made up of Greek men and women in the Washington, DC area with expertise in the public policy process. The goals are (1) educate policymakers about the positive impact of Greek life, (2) preserve the existing rights of fraternities/sororities, (3) advocate parity in government regulation and support collegiate quality of life issues, (4) identify opportunities for Greeks and government to work together to improve society; and (5) build a permanent Greek presence in Washington similar to the presence of other national trade associations.

Collegiate Housing and Infrastructure Act of 2003

In March of 2003, Representative Paul Ryan (R-WI) introduced the Collegiate Housing and Infrastructure Act of 2003 (H.R. 1523). The bill has 33 co-sponsors, including Martin Frost (D-TX) (Omega, University of Missouri). If signed into law, the bill would amend the Internal Revenue Code to permit organizations like the ZBT Foundation to accept tax-deductible contributions for collegiate housing and infrastructure improvements. Currently donations to the ZBT Foundation or local Chapter Housing Corporations for non-educational housing improvements are not tax-deductible.

Charitable Giving Act of 2003

Congressman Roy Blunt (R-MO) has introduced the Charitable Giving Act of 2003 (H.R. 7). The legislation would amend the Internal Revenue Code to allow for the deductions of small contributions to qualified non-profit organizations for those taxpayers who do not itemize. Further the bill would allow for tax-free distributions of individual retirement plans for charitable organizations.

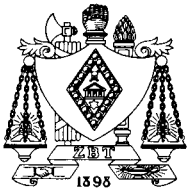
