#### **Letter from the International President**



Dear Brothers and Friends,

Dickens wrote "It was the best of times, it was the worst of times ..." This truly accurately describes the state of our Fraternity, and indeed the state of Fraternity in general in the United States. On the one hand, ZBT is ending a year with record new recruitment, strong financial performance, very low incidences of risk management issues and national recognition for our programming. On the other hand, the nation has had its fill of racists chants by fraternity men, hotels destroyed by fraternity men and sorority women, and yes, even public disrespecting of veterans by our own current and now-former brothers.

In all instances where our brothers have been involved in behavior unbecoming of a member of ZBT, we have worked hard to address the allegations and ensure that we react in a way that reflects the values of our Fraternity. In the case of the incident in Panama City Beach, we have worked

in partnership with local law enforcement and the relevant universities to understand the facts and to take appropriate actions to demonstrate our commitment to doing the right thing, even when it's difficult. We have a responsibility to hold ourselves and each other to the highest of standards, and to learn from instances where our behavior falls short.

As we addressed the challenges we have faced in recent months, we also have been working diligently to complete our new five-year strategic plan to lay out the goals of the ZBT Fraternity and Foundation. As I wrote in my inaugural letter, I believe that fraternity <u>can be</u> the greatest force for good on college campuses today. While that belief has been tested over the past weeks, I'm hopeful that events like those that took place in Panama City will force us all to focus on doing everything we can do to convince our campus partners, parents of prospective members, and future employers of our graduating brothers that brotherhood in ZBT prepares young men to be future leaders and positive contributors to society.

To demonstrate our commitment to this cause, I'm proud to lay out the tenets of our new strategic plan. This plan was developed by alumni from both the Foundation and Fraternity, as well as contributors from outside campus and Greek organizations. It was truly a collaborative and open effort.

This is what we will look like in 2020:

- 1. Revitalized undergraduate experience
  - a. We will demonstrate the clear link between skills learned as a brother and the 21st century skills needed to succeed in the modern workplace critical thinking, collaboration, expression, grit and self-awareness.
  - b. We will provide world-class training.
  - c. We will dramatically increase undergraduate/alumni interaction.
  - d. We will ensure that our chapters sustain our heritage by engaging with the Jewish community and by promoting tolerance.
- 2. Sustainable growth and expansion
  - a. We will refocus our expansion efforts on campuses where we can build strong, large chapters and provide the appropriate level of staff resources to ensure that new colonies have the best chance to survive and thrive.
  - b. We will grow our undergraduate membership to 6,000 (from near 5,000 today) by improving all of our chapters and expanding intelligently to new campuses.
  - c. We will become a model to our campus partners so they see the value we bring to their campuses.
- 3. New alumni experience
  - a. We will integrate the alumni experience into undergraduate life by recognizing that the alumni experiences starts in senior year.

- b. ZBT will become more relevant in the lives of our alumni by providing more enriching volunteer opportunities, valuable programming, networking opportunities and social engagement.
- c. We will encourage all of our chapters to actively recruit and, when possible, give bids to prime legacies.
- 4. Increased philanthropy
  - a. Our case for support from you will become much more compelling as we demonstrate that value that ZBT delivers to our undergraduates and members of our community.
- 5. Strong organizational capacity
  - a. We will provide best-in-class service to our undergraduate brothers and alumni.
  - b. We will invest in people, processes and technology to deliver on these goals.

This plan gives us a clear pathway to becoming a true force for good. Despite our recent challenges, I've never been more excited about the future of our Brotherhood. I look forward to working with anyone who shares our vision for the future and is willing to pitch in to help.

It's great to be a ZBT.

#### 3. What was the defining moment for you when you realized ZBT is for a lifetime?




#### 4. What is your best ZBT memory?

We were asked not to wear our uniforms that day to simulate civilian casualties. I just happened to put on a T-shirt with letters. During the exercise I was placed on a stretcher and was being taken to the field hospital. As I was being taken into the field hospital, one of the guards saw the T-shirt ... exclaimed "ZBT!" and saluted. It was a fairly surreal experience.




#### Nancy L. Simon 1928-2015

For 60 years or more, Nancy Simon was a ZBT Sweetheart, and no one ever carried the title with more affection from the Brotherhood. Wife, mother and twice grandmother of ZBTs, she was the Fraternity's and the North-American Interfraternity Conference's first lady during the presidency of her husband Richard S. (Dick) Simon, Phi (University of Michigan) '43, of both organizations. Her long, personal connection with the Fraternity favored her with a unique perspective on our affairs and an abiding concern for our Good and



Nancy had a special regard and hospitality for ZBT's young staffers who often spent months at a time on the road. Called Field Secretaries until the '90s and now Chapter Consultants, if she knew they were in Pittsburgh, they were invited for a home-cooked meal and an evening with the Simon family. It was at just such an evening this writer first met Nancy, now 50 years past.

Nancy's warm welcome, be it into her home or to a grand reception, was her hallmark. She loved being in the midst of people and she seemed to draw strength from them. If you were meeting Nancy for the first time, she made you feel like family, and if you were seeing her again, you instantly knew your pleasure was mutual. Always looking wonderful — just as though she stepped off the cover of a fashion magazine — her touch and tone were nevertheless casual and comfortable. Nothing was ever about her — it was

always about you. Even so, her response could be disarmingly frank while leaving no doubt about its good intention.

She enjoyed having fun as evidenced by being the family's only devotee of strong drink, rightly a source of some embarrassment to her more temperate fraternity men kin. A good joke was always welcomed and she saw no harm in a bit of time at the gaming venues. Her reputation



at the Bridge table, both for her skill and her good humor, was much admired. Nancy perfectly understood that if you want to go to the party, you need to be the party. There was never a ZBT who wasn't proud to be her escort or delighted to be in her company.



Someone said of Nancy, "She's not a lady who does lunch, she's far too busy doing good works." And so she did. Her volunteer activities included Women's American ORT, Israel Bonds, Brandeis University, Ladies Hospital Aid Society, United Jewish Federation's Women's Board, Jewish Family and Children's Services Resettlement Program, Temple board of trustees, chairman of the cemetery committee, Sisterhood board member.

Nancy's work was not restricted to the boardroom. She was gifted at the art of embroidery. Her beautiful Torah mantels and banners remain treasures of her congregation.

ZBT's success and good fortune over the years is not only of our own making. In the best and worst of times we've been cheered on from the sidelines by wives and girlfriends, moms and dads and folks who believed in us and the concept we espouse. Their support has often been more than just goodwill. Time, money and tangible contributions have frequently resulted from their involvement. It would be hubris to think we don't need them. Moreover, it would ungrateful to forget them. In an essential way, they too are ZBT. So it was with Nancy Simon. As she was for 65 years with her beloved husband Dick, she was the Fraternity's best friend.

#### **Obituaries**

#### Jules R. Lippert, Alpha Psi (Pennsylvania State University) '53

Jules R. Lippert, 83, of Newtown Square, who worked to help Jews blocked by the Soviet Union from immigrating to Israel, died Wednesday, Dec. 24, of natural causes at Bryn Mawr Hospital.

Mr. Lippert co-owned a prefabricated-house company, Hilton Lifetime Homes, in Blackwood. Beginning in the 1980s, he and his wife, Louise, began collecting and selling antiques. They specialized in small Victorian English items, particularly sewing tools used for fine needlework.

Starting in the 1970s, the couple developed a passion for helping Jews who were forbidden to leave the Soviet Union for Israel. Mr. Lippert, cochairman of the local Soviet Jewry Council, traveled to the Soviet Union several times to meet with such Jews, known as refuseniks.

His visits took him to Latvia, Lithuania, and Leningrad, and the couple offered support to Jews behind the Iron Curtain, bringing books and items for people to sell to raise money.

"We were afraid to talk in our rooms, and several times we felt that we were followed," Mr. Lippert's wife recalled. "It was a very uncomfortable kind of trip."

The couple also petitioned American political leaders to lobby the Soviet Union to allow Jews to emigrate. The work remained a part of their lives until just before the breakup of the Soviet Union.

Mr. Lippert, born in Riga, Latvia, barely escaped the horrors of the Third Reich. He and his mother were visiting her family in New York City in 1939 when World War II began. Their three-month visit turned into permanent emigration. They initially settled in Brooklyn and then moved to Philadelphia.

Mr. Lippert's father, grandparents, and cousins died in the Holocaust. An only child, Mr. Lippert gained siblings when his mother remarried and had two sons.

An alumnus of Lower Merion High School, Mr. Lippert attended Pennsylvania State University, where he was a member of the Zeta Beta Tau fraternity. When he was a senior, mutual friends arranged a blind date with a freshman that eventually led to marriage in 1956. After graduating, he served in the Korean War, but he stayed in contact with his future wife.

In addition to his wife, Mr. Lippert is survived by daughters Susan Crystal and Joanne; a son, James; two brothers; and seven grandchildren.

When he was in his 30s, Edward M. Oberman, a certified public accountant, found he needed something to get him through tax preparation seasons.

He chose getting in shape for triathlons.

"So he gets up very early, trains, goes to work," said his wife, Lee Ann. "Then he got hooked on the health benefits.

"It became a way of life."

A typical race might consist of swimming 400 to 500 yards, cycling 12 to 15 miles, and running three miles, according to the website www.active.com/triathlon.

Mr. Oberman dismissed the idea of jogging, his wife said, "because it's boring."

On March 9, Mr. Oberman, 50, of Sewell, who she said competed in more than 50 triathlons, died of cancer at home.

Born in Stamford, Conn., Mr. Oberman graduated from Rippowam High School in 1982 and earned a bachelor's degree in accounting at Widener University in 1986, where he was a member of Zeta Beta Tau fraternity.

As a certified public accountant, Mr. Oberman began his career with a firm in Darien, Conn., moved to the Stamford office of the former Price Waterhouse firm, and then transferred to its Philadelphia office.

In 1991, he opened his own accounting firm in Turnersville, Edward M. Oberman CPA, added financial planning 15 years ago, and sold it to partners in January.

Two weeks before he had the pain that signaled cancer in 2014, his wife said, he competed in his last event, the Escape the Cape Triathlon.

It began, she said, with competitors "jumping off the Cape May ferry." Mr. Oberman also competed in four Tough Mudder events, she said, which required teams to deal with obstacle courses.

He coached and sponsored girls' softball teams on which his daughters played "from when they were 5 years old until they were 16," his wife said. He helped fund basketball and softball teams in the Washington Township Division of Parks and Recreation.

And he took part in a program of the New Jersey Society of Certified Public Accountants, to interest students in the career.

A member of Temple Emanuel in Cherry Hill, he was a former treasurer of the Washington Township Chamber of Commerce.

# Making a difference in Guatemala

Since November of 2009, we have been participating in medical missions to Guatemala, along with a group of fellow volunteers and doctors. We travel to an impoverished city, Sumpango, in the region of Sacatepequez, where we provide medical attention to Guatemalan citizens, many of whom have never before been treated or seen by a doctor in their lives. People travel from across the country by foot to be seen on these missions, and often times we see up to thousands of people.

Emmaus Medical Mission travels to Guatemala twice a year, six months apart, with hopes of one day eradicating illness and disease from these people's lives. Going back every six months allows us the opportunity to follow up with patients who were seen on the last mission and to check in on how they have been doing since receiving medical attention just a few months prior.

There have been plenty of miracle cases in which our team has been able to fundraise to send certain patients to the United States for life-threatening illnesses that require immediate surgeries. And with some of the country's top doctors participating in these missions, we just want the people of Guatemala to know that no matter how difficult

things may be while we are gone, they are not forgotten, because we will always be back every six months.

During the course of each mission trip, we stay in an orphanage that serves as a home to children who have been abandoned, neglected and/or abused, in addition to many children who have neurological disorders. In many cases, children with neurological disorders such as autism, Down syndrome, intellectual disability and cerebral palsy have also been abandoned by their parents, or dropped off at the home because their parents were not able to financially care for them.

In a country where over 10,000 children are living on the streets, 10 percent of them will die from malnutrition. Misioneros Del Camino, the name of the home, has been taking in children for nearly 30 years now by one woman, Leonor Portela, more affectionately known as Mami Leo. Mami Leo was born in Cuba and moved to Miami, where she married her husband. He served as a pilot in the American Air Force andwas killed in action. Shortly thereafter, Mami Leo saw the devastating after-effects of a 1976 earthquake in Guatemala and all of the abandoned children on television and decided to do something about it. She sold her house, paid off her debts and, with only \$2,000 to her name, moved to Guatemala and built a home for children in need.

Mami Leo started her home with only six children she rescued from garbage dumps in the city and, since then, has saved thousands of children. There are currently over 100 children living in Misioneros Del Camino, and there is a neurological center on site, which provides various therapies to children from across the country with neurological disorders. The therapies include speech, sensorial, psychological, occupational, physical, and others, and they are completely free of charge to their families, paid for solely by donations. The goal of Misioneros Del Camino is not just to provide a shelter to children in need and to feed them, nor is it to provide therapies to children with disabilities and send them on their way. The goal is to provide a home to these children and give them something they did not previously have. And that is the gift of love.

These children are going to grow up with the love and support that they need to be law-abiding citizens who will go against Guatemalan societal norms. They will be the ones who study hard in school, respect their spouses, maintain a career and, most importantly, have a family with whom the love they received will be shared. That is how you break a defect in society.

We were asked to write about our experiences on these medical mission trips to Guatemala because of how "commendable" our work is. However, all we have really done is become passionate for a cause that we care about. And with that, we plan on continuing to follow in Mami Leo's footsteps by helping make a difference in the lives of the future generation in Guatemala.

ZBT has taught us that it only takes one person to make a difference, and we learned this through committee positions, executive board positions and leadership positions within ZBT International Headquarters. It only takes one person's desire, determination and persistence to make a difference in this world, and hopefully people will follow that person's lead. And that is all that we are trying to do.


